We have performed the procedures enumerated in Attachment I, which were agreed to by Sacramento City Unified School District (the "District") and the Measure I Oversight Committee (the "Committee"), solely to assist the Committee in evaluating District management's assertions concerning disbursement of Measure I Bond funds for the fiscal year ended June 30, 2006 as detailed in Attachment II. This agreed-upon procedures engagement was performed in accordance with standards established by the American Institute of Certified Public Accountants. The sufficiency of these procedures is solely the responsibility of the District and the Committee. Consequently, we make no representation regarding the sufficiency of the procedures described in Attachment I either for the purpose for which this report has been requested or for any other purpose.

The procedures performed and conclusions reached as a result of these procedures are identified in Attachment I.

We were not engaged to, and did not, perform an examination, the objective of which would be the expression of an opinion on management's assertions. Accordingly, we do not express such an opinion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.

This report is intended solely for the use of Sacramento City Unified School District and the Measure I Oversight Committee and should not be used by those who have not agreed to the procedures and taken responsibility for the sufficiency of the procedures for their purposes.

SACRAMENTO CITY UNIFIED SCHOOL DISTRICT PROCEDURES PERFORMED AND CONCLUSIONS

PROCEDURES PERFORMED

District management has prepared a report titled "Measure I Activity By Site" report (the "Report"), included as Attachment II, as of and for the year ended June 30, 2006, which provides site-specific information regarding Capital Facilities expenditures made with Measure I funds. We applied the following procedures to the Report:

- Verified the mathematical accuracy of the Report.
- Traced and agreed totals from the Report to detailed expenditure schedules.
- Verified mathematical accuracy of detailed expenditure schedules.
- Selected a sample of 111 expenditures representing \$30,856,427 (55% of total expenditures) identified on the detailed expenditure schedules. The sample of expenditures is included as Attachment III. The sample selection was designed to include a representative number of expenditures from each location identified in the Report. Verified that the expenditures represent valid expenditures, are properly charged to the location indicated, are properly coded as to the nature of the expenditure (account classification), and represent school improvements, not District teacher or administrator salaries.

CONCLUSIONS

- The Report and detailed expenditure schedules were materially mathematically accurate.
- Of the 111 expenditures tested:
 - All 111 expenditures represented valid Measure I expenditures.
 - All 111 expenditures were properly charged to the location indicated.
 - All 111 expenditures were properly coded as to the nature of the expenditure (account classification).
 - All 111 expenditures were determined to represent school improvements, not District teacher or administrator salaries.
