

Effective July 1, 2018, SCTA retirees may elect to participate in the Retiree Opt Out option, which allows retirees to purchase other insurance coverage of their choice. Examples of other insurance coverage include dental, vision, life, long term disability, long term care, cancer insurances and Medicare insurance costs per retiree's choice. In addition, the Opt Out option will allow medical health reimbursement. A retiree utilizing the Opt Out option must show proof of other health insurance coverage in order to receive an Opt Out Reimbursement. The reimbursement amount is up to **\$342.20** per month for qualifying expenses incurred during the period of July 1, 2018 through June 30, 2019. Additionally, a retiree may return to a District health program due to qualifying events.

Basic Pacific, Inc., (CBA) will handle Opt Out option reimbursements and related administrative processing on behalf of the District. For reimbursement, retirees must submit insurance premium receipts with the attached Claim for Reimbursement Form and send to CBA, via mail, fax or email.

**Important Information for 2018-19:**

- **PLEASE DO NOT MAIL CLAIM FORMS TO THE DISTRICT, AS THIS WILL DELAY THE PROCESSING OF YOUR CLAIMS.**
- The retiree must provide proof of the other health coverage before any reimbursements will be made.
- Claims will be accepted only during the plan year commencing July 1, 2018 through June 30, 2019. All submitted insurance premium receipts must represent coverage for this same period.
- All claims must be postmarked by July 15, 2019. Be sure to retain a copy of all claims and receipts for your records.
