Title I Part A: School Sites

Instruction Coordinators; Resource Teachers, Instructional Aides, Supplemental materials; Assessment & Intervention programs; Parent Resource Centers

Title II Part A: to increase the academic achievement of all students by improving teacher and principal quality. Funding is centrally managed.

2018-19 Allocation: **\$2,033,799**

Title II Part A: Centrally Managed

- Professional Development (Balanced Literacy, Common Core State Standards)
- Teacher Induction
- Common Planning Time

Title III: Support to English Learners

Title III English Learner: to ensure English learners attain English proficiency and reach high levels of academic attainment in English. Funding is centrally managed.

Title III Immigrant Education Program: to ensure that immigrant students meet the same challenging grade level and graduation standards as mainstream students.

ConApp Winter 2018-19 : Title IV Funds

Title IV Part A: to provide all students with access to a well-rounded education, improve conditions for student learning, and improve use of technology to improve the academic achievement and digital literacy of all students.

2018-19 Allocation: **\$1,225,684**
