Local Control Funding Formula (LCFF)

July 1, 2013 Governor Brown signed historic school funding legislation: the Local Control Funding Formula (LCFF).

"Today, I'm signing a bill that is truly revolutionary," said Governor Brown. "We are bringing government closer to the people, to the classroom where real decisions are made and directing the money where the need and the challenge is greatest. This is a good day for California, it's a good day for school kids and it's a good day for our future."



What Did LCFF Change?

Performance represented by a single performance indicator (API)	Performance represented by multiple performance indicators	




Three Pillars of LCFF

- Equity
- Local Control
- Continuous Improvement

<u>What is the Local Control and</u> <u>Accountability Plan (LCAP)?</u>

- LCAP is the plan that each district creates, outlining goals, and specific <u>actions</u> and <u>services</u> to achieve those goals.
- The plan includes expenditures that show which funds support the actions and services.
- The plan includes a review of data and actual expenditures in an Annual Update.



Accountability

- Evidence of support for each of the eight state priorities.
- Increased or improved services for identified students:
 - Low-income
 - English Learners
 - Homeless and Foster Youth
- How stakeholders were consulted as the district develops and updates the plan.






Three Levels of Funding

- LCFF Base Funding all districts receive a "per head" amount, based on attendance
- LCFF Supplemental Funds allocated by the number of low income, English learners and foster youth
- LCFF Concentration Grant additional amount for districts with over 55% of students receiving free/reduced price meals




How LCFF Funds Districts

- Support for Students who are English learners
- Foster Youth Services

Goal #2 Highlighted Districtwide Actions



- Plant Managers and Custodians
- School Resource Officers
- Central Office Drop Out and Attendance Support
- District Social Workers and Nurses
- Programs to support positive school climate, such as SEL, PBIS and Restorative Practices



Goal #3 Highlighted Districtwide Actions




- District Parent Engagement staff to support outreach, parent education and training
- Parent/Teacher Home Visit Project and Academic Parent-Teacher Teams
- Translation services throughout the district, both written and verbal.
- Fingerprinting fee payment



Local Control for Districts and Schools

- Approximately 25% of SCUSD Local Control Funds are allocated to school sites.
- LCFF funds are built into each school's Single Plan for Student Achievement (SPSA).

2016-17 Estimated Supplemental/Concentration Funds





Funds Allocated at School Sites

- Every SCUSD school receives a portion of LCFF based on the percent of Low income and English learner students.
- The use of funds is described in the Single Plan for Student Achievement (SPSA) created by the School Site Council (SSC).





Committee Purpose and Outcome(s)

Responsibilities:

- Synthesize other stakeholder input
- Participate in outreach activities
- Review progress reported in LCAP Annual Update
- Provide feedback on LCAP Draft

Primary Outcome:

• Comments provided to the Superintendent and BOE on the draft LCAP



Commitments Made

- One PAC meeting per month through June
- Participate in an orientation
- Attendance at [at least] one district LCAP workshop
- Consider serving a multi-year (2+) term
- Perform outreach by gathering input from his/her stakeholder community as a Public Education Volunteer
- Work collaboratively with other members of the committee and district staff throughout the process



District Role

Responsibilities:

- Organize and facilitate meetings to meet committee outcome
- Provide information to the committee on the district LCAP and other plans or tools that provide guidance to the work (Evaluation Rubrics, LEA Plan, SPSA, Strategic Plan, ELD Master Plan, etc.)
- Share data for informed discussion
- Ensure parity between LCAP PAC and EL PAC



Professional Learning Community (PLC) Facilitation

- Common understanding: tenets of LCFF; implementation of current LCAP; purpose of committee and members' roles and responsibilities
- Learning together: LCFF Evaluation Rubrics, LCAP Template
- Study topics / subcommittees: determined by the members
- Community outreach to all stakeholders
