## 2. VERIFICATION



**We also dispel myths about "raids" and false alarms!**

**The RR Hotline responds by sending Trained Moral and Legal Observers to document ICE Activity, gather information for legal team, and refer families to attorneys.**

## 3. ATTORNEY ACTIVATION AND LEGAL SUPPORT

**FUEL Network Legal Team receives referral from RR Hotline.**

**We work together to provide legal assistance to individuals who are at the ICE processing center, detained, and those who need long-term representation.**

## ***KNOW YOUR RIGHTS PRESENTATIONS***

Everyone has constitutional rights, regardless of who is president. This presentation includes updates on DACA, TPS, Laws and Policies Addressing Obstacles to Higher Education, Select CA Legislation, and KYR when encountering law enforcement.

## ***FAMILY EMERGENCY PLANNING ASSISTANCE***

This presentation will provide information and template documents that can be utilized for parents seeking to create emergency plans for their children in the event they are deported.

## ***LEGAL ASSISTANCE***

Legal Consultations to screen for remedies in a person's immigration situation or for individuals detained by Immigration & Customs Enforcement. Legal Representation for individuals in deportation proceeding, challenging immigration detention, and seeking bond. Legal Representation in affirmative applications for immigration status.

## ***MENTAL HEALTH SERVICES***

Individual and Group Therapy Sessions offered, specifically but not limited to immigrant and refugee families.
