### MEMORANDUM OF UNDERSTANDING-SACRAMENTO COUNTY OFFICE OF EDUCATION (SCOE) SELPA

The purpose of the MOU is to establish an agreement between the Sacramento County Office of Education (SCOE) Special Education Local Plan Area (SELPA) and the SELPA's in Elk Grove Unified School District (EGUSD), Sacramento City Unified School District (SCUSD) and San Juan Unified School District (SJUSD), describing the implementation of the Part C requirements for the California Early Start Program in Sacramento County.

### MEMORANDUM OF UNDERSTANDING-ALTA REGIONAL CENTER

The purpose of this agreement is to define, describe, and clarify each agency's policies and responsibilities including referral, evaluation and assessment, child find, fiscal responsibilities, service coordination, transition etc. as related to the implementation of the California Early Start Program in Sacramento County.
