Nyob rau hauv no yog koj tus menyuam cov qhabnia uas xeem lub xeev cov kev xeem xyoo tas los thaum lub caij nplooj ntoos hlav (spring) – the California Assessment of Student Performance and Progress, lossis CAASPP. Xeev California cov tub/ntxhais kawm ntawv nyob rau qib 3-8 thiab 11 koom rau cov kev xeem hauv online rau Askiv thiab Leb txawv tag nrho cov uas xeem tas los uas siv ntaub ntawv-thiab-xaum. Cov kev xeem no cov tub/ntxhais kawm ntawv yuav tsum tau ua tib zoo soj ntsuam tej ntaub ntawv, siv technology, daws cov teebmeem uas nyuaj tshaj, uatib zoo piav sau thiab tiv thaiv lawv cov lus teb. Cov kev xeem no yog tsim los pab rau tsev kawm ntawv kom paub tias tshuav yam kev kawm twg uas tu ncuu thiab kom txhawb pab tau cov tub/ntxhais kawm ntawv zoo dua tuaj.

Kawm kom paub cov kev peev xwm los mus xeem cov kev xeem no kom zoo tshaj mas yuav siv sijhawm thiab mob siab rau. Peb ntseeg tau tias yog mob siab tiag rau yuav tsum tsim nyog xwb vim peb cov tub/ntxhais kawm ntawv yuav tsum tau paub cov kev peev xwm no kom kawm tau mus rau qib siab college thiab cov kev kawm haujlwm.

Peb pom tau tias cov qhabnias ntawm ib tug tub/ntxhais kawm ntawv yog kev ntsuas ntawm nws lub peev xwm uas kawm tau zoo licias tiamsis tsis yog *tib qho* kev ntsuas nkaus xwb. Cov tsev kawm ntawv thiab cov xibfwb siv cov qhabnia uas xeem tau nrog rau ob peb yam uas muaj los qhia tias seem twg uas yuav tau mob siab rau ntiv thiab qhia tias tshuav yam twg uas muaj tsis txaus rau cov tub/ntxhais kawm ntawv. Peb pom tau tias cov kev xeem no yog ib qho kev soj ntsuam tias kawm tau zoo licias. Zoo ib yam li cov ntaub ntawv ua hauv chav kawm thiab cov qhabnia uas xa rau nram tsev, lawv yog cov tub/ntxhais kawm ntawv ib qho kev ntsuas tias kawm tau zoo licias.

Tag nrho peb sawv daws ntawm hauv paus tsev kawm ntawv Sacramento City Unified yeej sib zog ua haujlwm kawg kom paub tias tag nrho peb cov tub/ntxhais kawm ntawv ua tau li lawv cov hom phiaj uas npaj tseg los ntawm lub xeev tus qauv (California's Common Core State Standards). Hloov kev qhia ntawv thiab txheej txheem kom sib haum – thiab kho peb tej technology rau cov tshiab tam sim no – yuav tau ua lub siab ntev, lub sijhawm thiab txuas ntiv txoj kev nqis peev rau txoj kev kawm ntawv.

Kev hloov yeej tsis yooj yim, tiamsis peb ntseeg tau tias yim ua nyuaj npaum cas cov tub/ntxhais kawm ntawv yim kawm tau mus siab npaum ntawd – thiab nrhiav txoj hauv kev tshiab los mus ntsuas kev kawm tau– yuav pab tau cov tub/ntxhais kawm ntawv ua tau ntawv zoo rau kev kawm qib siab, tej chaw ua dejnum thiab lawv lub neej.
