### **BASIC FUNCTION:**

Perform a variety of specialized services and youth development specific activities to identified students and their families including screening, needs appraisal and evaluation, crisis intervention, in-home assistance, case management, referral, monitoring, and general support.

REPRESENTATIVE DUTIES: (Incumbents may perform any combination of the essential functions shown below [E]. This position description is not intended to be an exhaustive list of all duties, knowledge, or abilities associated with this classification, but is intended to accurately reflect the principle job elements.)

Work in conjunction with mental health clinicians and/or clinical supervisor to assess risk, and identify students/families in need of more intensive services.  $\bf E$ 

Assist in the implementation and coordination of youth development, alcohol, tobacco, and drug-free education, after school, and foster youth programs that meet the needs of families and children; coordinate activities related to gang, bullying, and violence prevention and intervention.  $\bf E$ 

Provide support to students and family members, and make home visits as needed; make visits to schools and community agencies as needed to meet with students and strengthen collaborative service efforts; drive a vehicle to conduct work.  $\bf E$ 

Serve as a resource to schools in the identification of strategies and training for prevention and cessation of tobacco, alcohol, and/or drug use; support the goals, objectives, and action plans developed by the funding agency; ensure compliance with laws and grant regulations.  $\bf E$ 

Act as a liaison with participating agencies to ensure the implementation of foster youth program services, such as educational assessments, facilitating transfer of educational records, tutoring, and instructional case management.  $\bf E$ 

Help students and families obtain resources to stabilize their lives through referrals to other community-based organizations.  ${\bf E}$ 

Maintain confidentiality of privileged information obtained in the course of work, and participate in school meetings related to case management of identified students.  $\bf E$ 

Work with school improvement initiatives that close student achievement gaps between racial, ethnic, and economic groups by working with all of the diverse communities.  $\bf E$ 

Operate a computer and related software; maintain appropriate records, conduct research, collect data, and prepare written reports as required. **E** 

Remain current and knowledgeable on advances in the field by attending trainings and reading professional publications.  $\bf E$ 

Perform related duties as assigned.

# SAMPLE PHYSICAL ABILITIES:

Hear and speak to make presentations, and exchange information in person and on the telephone; dexterity of hands and fingers to operate a computer keyboard; see to read, prepare documents and reports, and view a computer monitor; sit or stand for extended periods of time; bend at the waist, reach overhead, above the shoulders, and horizontally to retrieve and store files; lift light objects. Physical, mental, and emotional stamina to endure long hours under sometimes stressful conditions.
